

FEDERAL RESERVE

1. The Federal Reserve is a private corporation, owned and controlled mostly by foreign bankers.
2. Alan Greenspan (ex chair of the Fed) admitted on television that the Fed is above congress.
3. Every Federal Reserve Note (US Dollars) is an interest bearing debt instrument payable to private invisible bankers.
4. The Fed has no assets; it creates and issues money out of thin air while charging outrageous interest to the American taxpayer.
5. Thomas Jefferson very famously said "I believe that banking institutions are more dangerous to our liberties than standing armies."
6. On June 10, 1932, Congressman Louis McFadden, a long-time adversary to the Federal Reserve, made a 25-minute speech before the House of Representatives, in which he accused the Federal Reserve of deliberately causing the great depression.
7. Woodrow Wilson signed the Federal Reserve act into law. He later wrote that he was deceived into enacting the law, and when he was on his death bed he could be heard muttering "I have betrayed my country."
8. On April 22, 1935, Charles E Coughlin, an outspoken advocate against the fed, gave a speech at Madison Square Garden railing against the "exploiters and profiteers of mankind". While bankster enemy Heuy Long's Dec 11, 1935 powerful, but entertaining, speech titled "Share the Wealth" contested that 4% of the elite own 85% of the wealth in America stating "...who would let one man take off the table for what's intended for 9/10th of the people to eat." He also called out the perpetrators like JP Morgan, The Rockefeller's & Mellon. Long was assassinated by Dr. Carl Weiss Sept 8 1935, he died two days later in a hospital.

1. On any given night 150,000 - 300,000 Veterans are homeless.
